- March 1, 2023: All state and national awards deadline
- Families Acting for Community Traffic Safety (FACTS) each state is awarded \$500 cash award to the top FACTS project.
- March 1, the FCCLA NLC registration/hotels open. All chapters must register for NLC to receive the hotel info. California FCCLA suggests:





